Organisation Overview

The QCDG is an independent, incorporated, not-for-profit organisation which was founded and, is run by, claims professionals in Queensland.

The intention of the QCDG is to run quarterly educational and networking seminars for claims professionals in Queensland, to encourage and promote discussion and education in the ever-evolving insurance claims world. The focus of the group is to provide practically focused seminars to promote engagement of attendees at little or no cost to participants. In most cases the seminars will attract CPD/CIP points.

The QCDG will target claims professionals with varying degrees of seniority and experience, with a focus on topics which will target a wide array of personnel from different organisations and roles. Seminar topics will range from various topics including:

Handling of disputes and complaints in the claims process;
The impact of technology in the claims process, and how it can be utilised
more effectively;



2018 Sponsorship Terms and Conditions

- (i) Payment of the relevant sponsorship fee is required to gain access to the entitlements set out in this agreement.
- (ii) After sending your Sponsorship Application and Agreement to QLD Claims Discussion Group Inc. you will receive an invoice for payment, if accepted. Full payment must be received prior to receiving any sponsorship benefits.
- (iii) If you cancel your participation as sponsor after signing the Sponsorship Agreement, your organisation will remain liable for full payment of the applicable sponsorship fee.
- (iv) QLD Claims Discussion Group Inc. will endeavour to avoid major changes to the format of events agreed with event sponsors, however, sponsors acknowledge and agree that some changes to event formats may be required at the discretion of QLD Claims Discussion Group Inc.
- (v) Banner signage for events will be located at the discretion of QLD Claims Discussion Group Inc. unless otherwise agreed with QLD Claims Discussion Group Inc. All banners, at the sponsor's cost, are to be:
 - a) free-standing;
 - b) Produced and delivered to the venue; and
 - c) Uplifted by sponsors following the event.
